2. SPSA Implementation and Budget Update – Mr. Uriostequi

No discussion, motion was approved and carried.

a. Title I Budget Update

Mr. Uriostegui gave an update on the Title I Budget. He recommended that \$5,000 be moved from equipment to supplies to pay for 2,100 Life Skills Student Planners. Nancy Bloom motioned to move \$5,000 from equipment to supplies to pay for the student planners. Norma De Leon seconded motion. No discussion, motion was approved and carried. Mr. Uriostegui also recommended that \$1,500 be moved from equipment to transportation to pay for the bus transportation of AVID students visiting college campuses. Annette Kim motioned to move \$1,500 from equipment to transportation to pay for the bus transportation of AVID students visiting college campuses. Melissa Irving seconded motion. No discussion, motion was approved and carried.

- 3. SPSA Implementation and Budget Update Mrs. Park
  - a. LCFF Budget Update

Mrs. Park gave an update on the LCFF Budget. Mrs. Park recommended that \$150.00 be moved to substitutes from equipment to cover for a substitute for the mentor field trip. Glenna Buttrey motioned to move \$150.00 from equipment to substitutes to pay for the substitute. Norma De Leon seconded motion. No discussion, motion was approved and carried. Mrs. Park discussed Chrome Book Cart purchases with the council. Mr. Gonzalez informed the council that Orange High School's enrollment increased. We have an additional \$65,000.00 in LCFF funds because of the enrollment increase. Mrs. Park recommended that 60% of this money be moved to instructional supplies and 40% be moved to equipment. Alice Prothero motioned to have 60% of the \$65,000.00 be moved to instructional supplies and 40% of the \$65,000.00 be moved to equipment. Nancy Bloom seconded motion. No discussion, motion was approved and carried.

4. Principal's Report- Mr. Gonzalez

Mr. Gonzalez informed the council that Orange High School's enrollment increased. We have an additional \$65,000.00 in LCFF funds because of the enrollment increase.

## 5. EL Update- Mrs. Park

Mrs. Park reviewed the district's EL Reclassification Procedures, the school's Language Census, EL Data, CELDT Report, and the Analysis of Current Educational Practices-EL.
