### **Confirmation of Membership**

Motion made for the School Site Council (SSC) to formally approve SSC members by Ana Gutierrez-Olivarez, seconded by Cynthia Hicks, all in favor.

## Officer roles, Chairperson, Vice Chairperson & Secretary

Raeanne Little distributed the roles and responsibilities of the SSC members to review and solicit questions. Jennifer Cisneros was asked if she would continue her role as Secretary from 2015-2016. She accepted. Raeanne Little then asked if any members would like to accept the role of Chairperson and Jody McGuire stated he would step into the role.

Motion made for the SSC to formally approve Jody McGuire as SSC Chairperson by Raeanne Little, seconded by Ana Gutierrez-Olivarez, all in favor.

A request was then made for a Vice Chairperson, which Cynthia Hicks offered to fill.

Motion made for the SSC to formally approve Cynthia Hicks as SSC Vice Chairperson by Jody McGuire, seconded by Mrs. Houlihan, all in favor.

#### **School Site Council Purpose and Responsibilities**

SSC members were asked to review the SSC By Laws. A recommendation was made to review the By Laws and pass one motion to approve all discussed changes/edits by Jody McGuire.

Motion made for the SSC to formally change the By Laws by the next scheduled SSC meeting to reflect the following changes by Jody McGuire, seconded by Ana Gutierrez-Olivarez, all in favor.

- Article II: Change "2 Other school staff members" to 1 Other school staff member"
- Article II: Remove "shall be an ex officio member of the school site council
- Article III, Sectary Shall: Change "and to the following other persons: Larry Hausner, principal" to "and to the principal."
- Article III, Section B: Amend "The officers shall be elected annually, at the back to school night meeting of the school site council..." to "The officers shall be elected within the first 6-weeks of school of the school site council..."
- Article III, Section C: Change "...two-thirds vote of all the members." to "...two thirds vote of all the School Site Council members."
- Article V, Section A: Change "The school site council shall meet regularly on the \_\_\_\_ school day of each month" to "An agreed upon calendar will be determined at the first school site council meeting and posted on the school website."

#### Schedule of Meetings for 2016-2017

Raeanne Little explained that two requirements of the SSC was to approve the schools Single Plan for Student Achievement (SPSA) and the School Safety Plan. There has been a shift in when the approved SPSA is due to the district office and does not align with the proposed 2016-2017 meeting schedule. Raeanne Little agreed to send a draft of the SPSA to the SSC members the week of October 24<sup>th</sup> for review prior to the our meeting.
